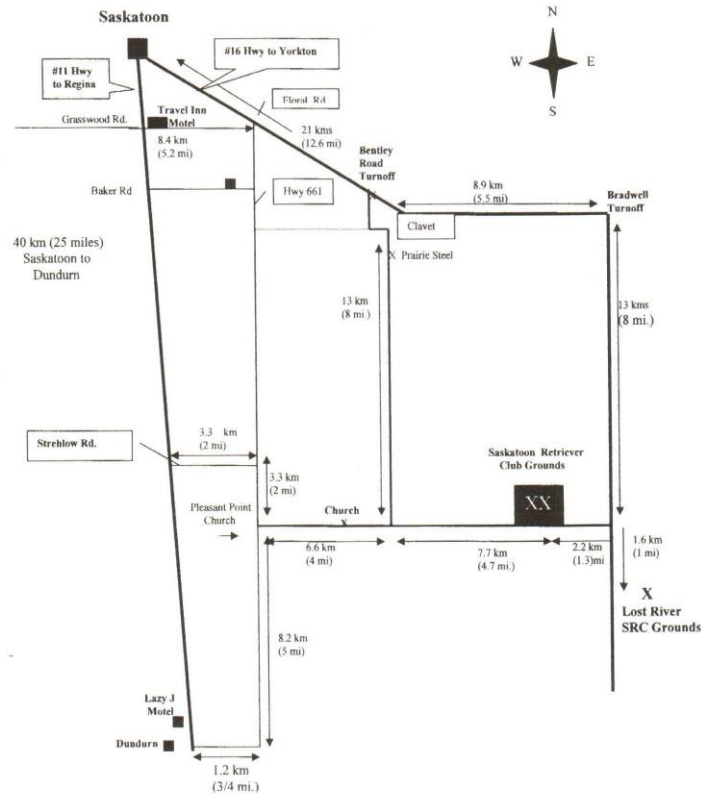

- ◆ Cheques payable to the Saskatoon Retriever Club (Canadian Funds). Must be dated no later than the closing date. Mail early. Email entries accepted with signed and legible entry form and must be accompanied by an e-transfer payment only. No e-transfers accepted for mailed entries. **NO PHONE OR FAX ENTRIES WILL BE ACCEPTED.**
- ◆ **NO LATE ENTRIES** will be accepted as in accordance to CKC rules. **Entries close Sunday Sept. 13th, 2020 6:00pm for Saturday test.**

- ◆ All entries must be accompanied by the full entry fee. A listing fee of \$10:00 + 5% GST = \$10.50 shall accompany an entry **IF** the dog does not have an individual CKC registration number or ERN number.
- ◆ Running order will be determined by a draw on Tuesday morning, September 15th. Multiple entries by the same owner/handler will be automatically separated unless otherwise requested.
- ◆ Pigeons, ducks or pheasants may be used on land and ducks will be used in the water.
- ◆ Standard CKC Rosettes to all dogs qualifying in each event.

Policy Regarding Non-Members of the CKC

A non-member participation fee of \$64 +5% GST=\$67.20 will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs wholly owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title

being withheld and the dog cannot be moved up to the next level.

**It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

IMPORTANT PARTICIPANT INFORMATION: Due to COVID-19, we are implementing the following new processes for this event.

1. No food or drinks will be provided. Participants and volunteers must bring their own refreshments
2. The club will not be hosting a tailgate party.
3. Ribbons will be handed out after the end of each stakes by the club house.
4. All participants and guests must follow social distancing protocols. Sanitizing areas will be available at the various stakes.
5. Participants must adhere to all Province of Saskatchewan protocols, including not attending the event if they are sick, have any COVID-19 symptoms, have been in contact with persons with COVID-19 or have travelled within the last 14 days
6. Sanitizing station will be available for all participants to use prior to going to the holding blind and after they run. We ask everyone to limit contact with the blind.

SCRATCHES

Scratched entries will forfeit \$10.00 per entry when trial secretary is notified at least one hour in advance of the starting time on day of test. 'No shows' will forfeit full entry. Bitches in heat will be provided a full refund as they are not to be on test grounds at any WC Event.
