Any person participating in any capacity at a Field Trial held under these rules shall not be subjected to any indignity of any kind during the process of the trial and it shall be the duty and the obligation of the Club holding the trial to see that this rule is effectively carried out. On report to the trial-giving club of an alleged indignity of any kind the Field Trial Committee of the Club shall forthwith conduct an investigation and shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.

GROUNDS

The trial grounds are located about 35km (22 miles) SE of Saskatoon. See map.

There WILL NOT be a lunch wagon, so bring your own food and drink.

Note: Electrical Sites are 15 amp outlets, cannot handle heaters or air conditioners

ENTRIES

3. Entries **CLOSE Monday, June 21, 2021**

4. DRAW will take place at 8:00 a.m. Tuesday, June 22nd at the home of the Field Trial Secretary.

All dogs will run in the order drawn.

5. The starting dog number in the first series of the Open on Monday will be determined by using the last two digits (including digits, if any, to the right of the decimal point) at closing of the Toronto Stock Exchange (TSE) S&P/TSX composite index on the Friday immediately preceding the trial.

6. **A separate entry form for EACH dog in EACH stake is required (Official CKC Entry Form)**

7. All entries must be accompanied by the entry fee (and listing fee if applicable). The listing fee of **\$10.50 (GST included) per dog per event** is payable unless the entered dog has a CKC individual registration number or an ERN number.

Standard CKC rosettes to all dogs placing in each stake.

Certificate of Merit awards at the Judges' discretion

A system of rotation will be used in the All Age Stakes

A winger may be used in all stakes

8. Award system: First: 5 pts, Second: 3pts. Third: 2 pts. Fourth: 1 pt.

SCRATCHES

Approved scratches will forfeit \$10 per entry. No show refunds must be requested in writing to the FT Secretary within 14 days of the trial event.


NOTE: New Non-member participation fee

a) Beginning in 2011, an annual non-member participation fee for awards (placings) and titles will be charged to all Canadian residents who participate in a CKC event but are not CKC members. The fee will match the ERN fee.

b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards (points) and titles to be cancelled. Once cancelled the awards, legs, points or titles will be given to the next applicable dog.

c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members or dogs co-owned with a CKC member.

COVID REGULATIONS: SASKATOON RETRIEVER CLUB FIELD TRIAL – UPDATED June 21, 2021

For the safety of everyone involved, the Saskatoon Retriever Club asks that all adult participants and spectators should have received at least one vaccination against Covid-19 before attending this event.

Officials and participants are required to follow local and provincial Covid regulations.

1. Practice physical distancing, maintaining 6 feet/2 meters between individuals /households whenever possible.
2. Judges will attempt to physically distance during judging and will complete their deliberations outside whenever possible. If there is inclement weather judges can complete deliberations inside a truck and masks will be available if they wish to wear them. Judges should bring their own pencils, judging books and rulebooks for use during the event. Hand sanitizer, masks and gloves will be provided by the club for the judges each day. Judges chairs will be sanitized before the event and will be labelled with the judge's name so they use the same chair all day.
3. Handlers may be asked to deposit their birds in a pail or drying rack next to the line. If the judges wish to inspect a particular retrieved bird they will either remove the bird from the pail or will ask the marshall to get it for them. Some judges may ask a marshall to take birds from handlers at the line to deposit them in the pails or on the drying rack. If this is requested, gloves will be available for the marshall if they wish to wear them.
4. Judges, marshalls, and competitors in holding blinds should maintain a safe distance (>12 feet/4 meters) from each other and from the handler on the line whenever possible because blowing a whistle or duck call has the potential to project a vapor. Masks will be available for the marshalls and judges if they wish to use them.
5. A maximum of 20 handlers will be allowed behind the line at one time to watch the test dog and see the throws from the line. Persons not running a dog in the next test should not gather behind the line to watch the test dog.
6. Special instructions from judges will be posted in the holding blind.
7. When an honour is part of a test, the honouring dog and handler will be positioned at least 12 feet/4 meters from the running dog and handler.
8. Realizing that trials are an opportunity to see friends that you may not have seen in a long time due to COVID, it is important to try to refrain from hugging or shaking hands or other close contact with individuals not in your household. Maintain physical distancing.
9. Competitors and spectators will be allowed to gather in a specified area (gallery) to watch the tests , ideally remaining seated in their own chairs, and maintaining > 6 feet/2 meters physical distancing between household groups.
10. Judges and throwers and marshalls will be given a bag lunch and drinks. Judges will each have an individual cooler with lunch and drinks. There will be a cooler containing the lunches for marshalls and throwers, with the lunches labeled. There will be another cooler containing cold water for throwers, marshalls and judges.
11. Throwers will have one sanitized chair with their name on it provided by the club that they will use for each series. They will also be provided with disposable gloves and with hand sanitizer that they can use if they wish. Throwers from separate households should not congregate between tests, and should maintain physical distancing.
12. If an ATV is used it should be sanitized after each use/ before being used by a new worker.
13. Everyone (officials, competitors and spectators) entering the trial location does so with the understanding that (a) they have not tested positive for COVID-19 within the last 14 days, (b) they are not awaiting the result of a COVID-19 test, (c) they have not had any symptoms consistent with COVID-19 infection in the past 14 days, (d) they have not been exposed to anyone with suspected or confirmed COVID-19 in the past 14 days. If any of these statements are not true then they should not attend the trial. The field trial secretary has a list of everyone who attends the trial, and their contact information to allow for contact tracing if an outbreak occurs.

14. If in the 14 days after attending the trial an individual develops symptoms and/or a positive test for COVID-19 they should let the Club know so that contact tracing can occur.

15. Gloves will be available for the event secretary if she wishes to wear gloves while handling paperwork from the judges.

16. Awards will be announced outside, with physical distancing required. Ribbons can be picked up from the awards table – no hand shaking or hugging.

17. There will be no judge's dinner, tailgate meals or official Club BBQ. Individuals staying in the campground can use the club BBQs but should regularly sanitize the cooking utensils and BBQs. Group gathering for meals should follow physical distancing rules.

18. Access to the Clubhouse will be limited to a few Club workers who need to access the awards and paperwork and coolers. There will be no congregating indoors, even if there is inclement weather.

19. The outhouse doorknobs and toilet seats will be sanitized by a designated worker before the event and at least once each day during the event. There will be hand sanitizer available in each outhouse. Disinfectant wipes will be in each outhouse and users will be asked to disinfect the doorknobs and toilet seats after each use, depositing the wipes in the trash bin.

20. Camping in the Campground area will be allowed. Any socializing should be outdoors, and physical distancing maintained between household groups.
