## **HOW TO QUALIFY**

The 2023 National Master Hunt Test is open to:

- Any dog with a CKC Master Hunter title or AKC Master Hunter title who has successfully completed two CKC Master Hunter passes\* at hunt tests hosted by clubs in good standing of the Canadian National Master Retriever Club during the period of August 4, 2022 to August 9, 2023
- Any dog with a CKC Grand Master Hunter title
- Any dog that qualified in the most recent National Master Hunt Test
- Any dog that qualified in the 2022 AKC Master National Hunt Test

\*Note: the two qualifying passes may count towards the Master Hunter title

## **INFORMATION FOR EXHIBITORS**

#### Health

This notice is to provide clubs with a reminder regarding the rules and regulations for the health of all dogs on the event premises.

No dog may be brought onto the grounds or event premises if it:

- 1. is known to have distemper, parvovirus, kennel cough or other communicable disease,
- 2. has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event), or
- 3. has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

### **Behaviour and Conduct**

The Canadian National Master Hunt Test adheres to the CKC Rules and Regulations regarding all conduct and behaviour on the grounds. Additionally:

• After a series has begun, no participating dog shall leave the area of the series until after either it is tested and excused by the Marshal, or it is otherwise excused by the Hunt Test Committee

- No dog shall be exercised, trained or worked on the grounds for the duration of the test with the exception of bumpers thrown by handlers in approved areas only for the purpose of exercising the dog
- Designated exercise areas will be clearly defined and shall not be used for working or training purposes
- Any dog not entered in the stake and interfering with the running of the stake may be required to be removed
- Dogs not appearing on the line upon being called will be given 15min to do so otherwise they will be disqualified
- Rotation of starting dogs will be directed by the Marshal

### Entry

The entry fee is \$250CAD per running dog. Any dog which does not have an individual CKC registration number, must have a CKC TCN or ERN (if foreign), CKC PEN or CKC MCN. An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of the CKC. **The fee will match the ERN fee**. The non-member participation fee is \$170CAD plus tax.

Entries will close August 9, 2023. Please direct inquiries to the secretary at <u>secretary.2023nationalmaster@gmail.com</u>. All entries must be submitted via <u>www.dogshow.ca</u>.

### Scratches

Bitches in season may not compete and must be withdrawn. All entry fees paid will be refunded provided that a hard copy of a veterinarian letter is provided to the secretary before the test begins. If the dog is found to be in season at the official vetting, the assessment of the official veterinarian shall also be considered as sufficient proof.

Entry fees paid for a dog withdrawn due to injury, illness or death shall be refunded in full provided that a hard copy veterinarian letter is received by the secretary no later than seven days after the completion of the stake.

Otherwise, any scratches that occur after the closing date of August 9, 2023, will not have entry fees refunded.

### **Vetting of Bitches**

All entered bitches shall be examined by the official veterinarian at the SRC headquarters on Sunday August 20, 2023, at 1PM. Spayed females will be exempted from vetting if a veterinary certificate of spaying accompanies the entry form.

### Awards

All dogs receiving a qualifying score will receive a duck band, rosette and the title of National Master Hunter and shall be entitled to add the NMH prefix to the registered name.

### **Training Sites**

Training will be available on the SRC grounds until August 16, 2023 however, no birds can be used on the grounds after August 12<sup>th</sup>, 2023. From August 16<sup>th</sup>-26<sup>th</sup>, 2023 off-site training grounds will be designated and information regarding these sites will be available at the SRC headquarters.

### The Event

On Monday, August 21, 2023 at 7:30AM the caravan of entrants and spectators will depart the SRC clubhouse to the site of the first test. The official test dog will demonstrate the test at 8AM to start each day of the event.

All handlers and workers must wear dark or camouflaged clothing or customary hunting attire.

Ducks and/or pheasants will be used in all series. Live pheasants may be used for the upland test.

## NOTICE TO EXHIBITORS

#### Canadian Kennel Club Caution

It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at a hunt test held under these rules is not subject to any indignities of any kind. The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Rule 3.8.1 of the Hunt Test rules and regulations** states "any person at a hunt test held under these rules shall not be subjected to any indignities of any kind during the progress of the hunt test. It shall be the duty and obligation of the club holding the hunt test to see that this rule is effectively carried out.

The Saskatoon Retriever Club will not be responsible for any loss or damage to any dog or to any equipment, whether the result of an accident or otherwise. Furthermore, the Saskatoon Retriever Club will assume no liability in the event of an accident or other misfortune to event participants, bystanders, club members, workers or other individuals using the property for any purpose.


#### Release and indemnification of Landowners and the Saskatoon Retriever Club
