INFORMATION FOR EXHIBITORS

1. Dogs without an individual registration number (RN) or event registration number (ERN) and entered with a Temporary Competition Number (TCN) are required to pay a \$10.50 listing fee (GST included)
2. A non-member participation fee, for awards and titles, will be charged to Canadian non-members of CKC. Exhibitors have the choice to become a CKC member or pay the non-member participation fee.
Failure to comply within 30 days of notification will result in cancellation of awards and titles
3. Female dogs in season are not eligible for entry
4. Scratched entries will forfeit \$10.00 per entry when trial secretary is notified at least 24hrs prior to the starting time of test. **'No shows' or scratches within 24hrs** of event start time will forfeit full entry. Females in season will be provided a full refund as they are not to be on test grounds at any WC event
5. If a dog is not present within 15min of being called to the line, it may be disqualified
6. CKC Rosettes will be awarded to all qualifying dogs in each event
7. Local thawed from frozen local birds including but not limited to ducks, pheasants, chukars or guinea hens may be used
8. In working certificate test, gunners, throwers or handlers shall not wear distinctively white or light clothing at any time but handlers may wear handling jackets for the blinds in the WCX

9. There shall be no training of dogs on the test grounds starting 24 hours prior to event and ending upon event completion
10. Running order will be determined at random and published prior to start of the event

NOTICE TO EXHIBITORS

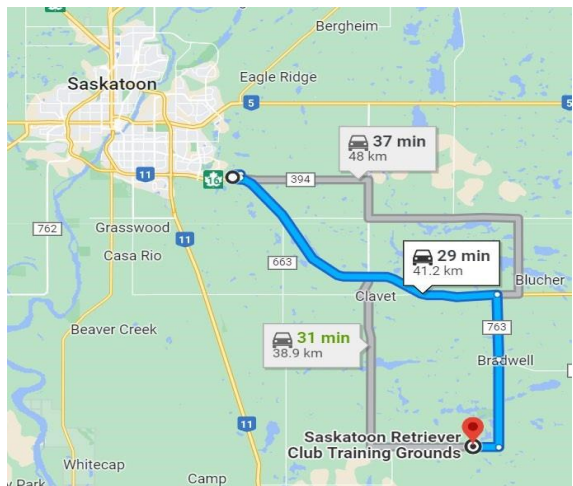
1. It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
2. The Saskatoon Retriever Club will not be responsible for any loss or damage to any dog or to any equipment, whether the result of an accident or otherwise.
